

The Director has committed the Agency to a search for U.S. citizens who may have suffered aftereffects as a result of their having been unwitting participants in drug experimentation sponsored by the Agency. We do not know the identity of any of the subjects of the testing and will have to try to reach them through the persons and institutions that conducted the research.

2. Attached is a list of people known to have been involved in MKULTRA research. In an effort to learn as much as we can about the full extent of their involvement, we are trying to establish what the full range of their relationships with the Agency may have been. Toward this end, we would like to have the opportunity to review any 201 files that may have been established for any of the individuals listed. In addition, we would like the opportunity to review any files the Operations Directorate may have on George H. White (aka Morgan Hall) former OSS and Bureau of Narcotics, deceased, and Charles H. Siragusa (aka Carl Salerno), Bureau of Narcotics. These two individuals were used by the Agency in covert capacities during the 1950's and may have been subjects of 201 files;
